> ABOUT THIS WEBINAR

Waterborne disease from pathogen-colonized building water systems is significant and increasing, both in the U.S. and worldwide. Attention has been focused primarily on Legionella, but the disease burden from other pathogens also is considerable. In 2015, ASHRAE published Standard 188, the first industry consensus standard addressing the management of Legionella risk from building water systems. In 2017, CMS issued a memo clarifying the coverage of its requirements for the management of risk from Legionella and other waterborne pathogens. In 2020, ASHRAE issued Guideline 12-2020, Managing the Risk of Legionellosis Associated with Building Water Systems. In March 2021, TJC released its new water management requirements for healthcare facilities, with specific reference to ASHRAE 188. In this webinar, the presenters will review the new TJC/CMS requirements in the context of ASHRAE 188 and ASHRAE Guideline 12 and will discuss practical implications of the new requirements.




